**4. First-aid Measures**

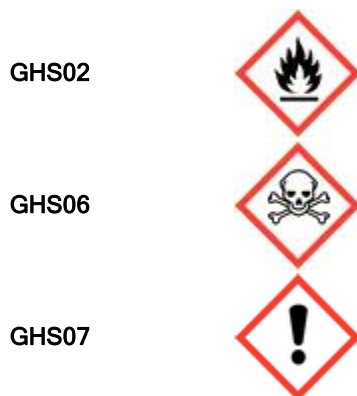
