Use only C33 Colorants. 15% max tint loads for most colors. Burnt Umber and Quin Red use at 2% max. Do not use 896 colorants!

DIRECTIONS:

Mohawk EnduraGreen® Ultra Pigmented Sealer is to be applied to sanded wood substrates. Sand substrate with 120-180 grit sandpaper prior to finishing. Mix Ultra Pigmented Sealer thoroughly and apply a full wet coat, 3-4 wet mils, to the sanded surface. Allow to dry 30-60 minutes and sand with 220-320 grit sandpaper to level the surface. Remove all sanding debris. Apply second coat if needed and follow same procedure as 1st coat. Sand Ultra Pigmented Sealer with 220-320 grit sandpaper and remove all sanding debris with a lint free cloth prior to applying topcoat. Apply appropriate topcoat according to manufacturer's directions within 4-6 hours of sanding the sealer for maximum adhesion. Total dry film build not to exceed 4 mils in the total finish system. Note: Add clean water to reduce products as needed.
