**Product Description:** Mohawk's "Hot Stuff Instant Glue" system is available in three (3) different viscosity levels. The highest viscosity is suitable for use on items with the greatest gap difference between parts to be bonded. The Mohawk M745-3540 accelerator is used to decrease the time necessary to bond.
